## 2015 Special Project Grantees

### **Behavioral Health Response**

*Safety First Suicide Follow-Up Program, St. Louis Metro/St. Louis County*

Suicide is the 9th leading cause of death in BHR's service area; suicide rates are increasing, and individuals at-risk have limited options for urgent treatment. BHR proposes a comprehensive telephone follow-up program that will save lives by enhancing the continuum of care for those at risk of suicide.

### **Bi-State Development Research Institute**

*Feasibility Study for the Implementation of On-Site Medical Services at MetroLink Station, St. Louis Metro/St. Louis County*

This project will create a business model for the development of healthcare clinics at MetroLink stations for the provision of routine, non-emergent healthcare services to transit-dependent populations. The use of existing infrastructure will expedite development and improve accessibility to community healthcare services for residents across North St. Louis County.

### **BJC Behavioral Health**

*Embedded school mental health services, St. Louis Metro/St. Louis City*

Embedded Charter School Mental Health Services will assist students struggling with trauma, dysfunctional family structures, homelessness, abuse/neglect, and/or life in neighborhoods of high poverty, recurring violence, crime, and drug abuse by providing a continuum of mental health services in the school and in partnership with school staff and student's families.

### **Bridgeway Behavioral Health**

*Integration of Treatment and Medicine, St. Louis Metro/St. Louis City*

Bridgeway Behavioral Health will provide on-site, primary care services - and intensive case management for referrals and resource linkages - to 1700 high risk/high need individuals presenting for co-occurring addiction and mental health treatment. The program aims to reduce barriers to healthcare, and to increase health literacy.

### **Community Partnership of the Ozarks**

*Greene County Triple P, Southwest/Greene*

Community Partnership of the Ozarks' CAN Collaborative is committed to ending child abuse and neglect in Greene County, Missouri. Triple P will be a tool to help us strengthen families and bring a community wide culture shift in parenting norms that will impact our community for generations.



## **in2Action**

### **Successful and Permanent Transition Project, *Central/Boone***

The project will address local health gaps for justice-involved people with co-occurring conditions by providing valid assessments, computer-based CBT, increasing bed space, and improved data collection and evaluation for residential consumers at in2Action. Long term impacts include improved life functioning for target population and improved public safety for the community.

## **Jordan Valley Community Health Center**

### **Emergency Department Diversion, *Southwest/Greene***

The Emergency Dental Diversion Initiative links patients who present in hospital emergency departments with oral health issues to Jordan Valley Community Health Center for care. The goal is that patients receive care in the correct environment; establishing them within a patient centered health home to avoid future emergency department over-utilization.

## **Legal Services of Eastern Missouri, Inc.**

### **Improving Health through Medical-Legal Partnerships, *St. Louis Metro/St. Louis City***

Legal Services of Eastern Missouri proposes a medical-legal partnership at two St. Louis community health centers to improve patient health through advocacy on social and environmental factors impacting health. The project's target population is both patients and health care providers at Affinia Healthcare and Family Care Healthcare.

## **Missouri KidsFirst**

### **Enhancing Evidence-Based Mental Health Services in Missouri Child Advocacy Centers, *All regions***

Child abuse victims have improved lifelong health outcomes when they have access to evidence-based trauma-focused mental health services. Currently, there are wide disparities in these services provided by child advocacy centers (CACs). This project will increase availability, quality and access to trauma-focused mental health services for children served by CACs.

## **Missouri Primary Care Association**

### **Improving Chronic Pain in Primary Care Health Homes, *All regions***

Primary Care Health Homes will improve chronic pain management by adopting the bio-psychosocial approach, including primary, pain specialist, and behavioral health care, within a population health management system, incorporating pharmacist consultation, patient engagement and self-management support, case-based learning, care team training, and care management utilizing integrated clinical and claims data.

## **National Council on Alcoholism and Drug Abuse - St. Louis Area**

### **Heroin Awareness Enhancement, *St. Louis Metro/Washington***

To combat the region's heroin/opiate epidemic, NCADA intends to add provocative, emotionally charged public service announcements to its arsenal of awareness-raising, attitude-changing tools. This project is intended to change beliefs and behaviors with the ultimate goal of significantly lowering the number of fatal and non-fatal heroin overdoses in eastern Missouri.



## **OASIS Institute**

Reducing Falls Through Collaboration, *St. Louis Metro/St. Louis City*

OASIS, leading the St. Louis Metropolitan Integrated Health Collaborative, will impact falls among adults ages 60+ through 1) screening, 2) reducing fear of falling, and 3) increasing physical activity. Over 2 years, 700 individuals will take part in the program, creating a collaborative model for recruitment, implementation and evaluation.

## **Ozark County Health Department**

ABC of Diabetes (Actions to Be in Control of Diabetes), *Southeast/Ozark*

The ABC of Diabetes project bridges a critical education gap in Ozark County by providing individual and group diabetes self-management education (DSME) in a local community setting where no such services currently exist.

## **PedNet Coalition**

Vision Zero: Eliminating traffic fatalities and serious injuries, *Central/Boone*

PedNet Coalition will lead a campaign to reduce Columbia, Missouri's high rate of traffic fatalities and serious injuries by passing a Vision Zero policy. Vision Zero is a data-driven strategy that influences transportation culture, policy, design, and enforcement in order to move communities toward zero traffic fatalities or serious injuries.

## **Phoenix Programs, Inc.**

Acceptance and Commitment Therapy (ACT) for Anxiety Treatment, *Central/Boone*

The Acceptance and Commitment Therapy (ACT) project will provide training, structured clinical development, strengthened referral relationships and provide ongoing individual and group counseling to address those with anxiety disorders or those who struggle with anxiety and stress. ACT is an emerging best practice nationally not yet widely available in Missouri.

## **Pike County Health Department, Home Care and Hospice**

Pike County Behavioral Health Services, *Northeast/Pike*

The Pike County Behavioral Health Program will increase access to behavioral health and social support services for low-income, underserved residents of Pike County through the development of a coordinated care management system for individuals suffering from mental illness, addiction and/or co-occurring substance use disorders.

## **Preferred Family Healthcare, Inc.**

DD Health Home Pilot, *Northeast/Marion*

Preferred Family Healthcare, Clarity Healthcare, Marion County Board for the Developmentally Disabled, UMKC-Institute for Human Development, and the Department of Mental Health will develop and evaluate a patient centered medical home (PCMH) focused on improved access to health care, including behavioral and oral health care, for individuals with developmental disabilities.



## **Putnam County Memorial Hospital**

*Breast Health Initiative, Northeast/Putnam*

Putnam County Memorial Hospital (PCMH) and collaborating partners plan to implement a breast health program that will aid early detection of breast cancer by (1) increasing screening rates in Putnam and surrounding counties that are below state average and (2) providing education and outreach services to raise public awareness.

## **Saint Louis University**

*Steps to Better Health for Immigrants and Refugees, St. Louis Metro/St. Louis County*

Saint Louis University and Bilingual International Assistant Services propose to partner on a pilot project to improve healthcare interactions and outcomes for immigrants and refugees. Grant funds will allow the project team—mostly immigrants themselves—to facilitate changes in health behaviors that have proven challenging to immigrants.

## **SSM Health Businesses**

*The City of St. Louis eHome Project, St. Louis Metro/St. Louis City*

The City of St. Louis eHome Project will provide telehealth services to patients who are discharged from the hospital to SSM Home Care in the City of St. Louis. SSM will collaborate with the St. Louis Area Agency on Aging (SLAAA).

## **St. Anthony's Medical Center**

*Intensive Outpatient Program Serving Jefferson County, St. Louis Metro/Jefferson*

Hyland Behavioral Health will provide an Intensive Outpatient Program for underinsured teens with behavioral health issues residing in Jefferson County, Missouri. Utilizing a multidisciplinary team approach, staff will work closely with parents and schools to provide comprehensive mental health treatment and support services, ensuring positive long-term outcomes.

## **St. Vincent Home for Children**

*Substance Abuse Treatment Program, St. Louis Metro/St. Louis County*

Serving St. Louis City and St. Louis County, LifeRecover is a no-fee intensive 60 day outpatient treatment program for adolescents who abuse substances that provides therapeutic counseling, addiction education, relapse prevention and supports long-term recovery. LifeRecover encourages responsible changes in behavior that promote healthier lifestyles and relationships.

## **Susanna Wesley Family Learning Center**

*Improving Health Through Trauma Informed Care, Southeast/Mississippi*

This is a new project that consists of intensive trauma informed care paired with recreational activities for children and adults residing in Mississippi County that have suffered multilayered trauma. The project will attempt to reduce the effects of trauma which will result in healthier lives for the individuals impacted.
