2020 Health-Related Legislation Under Consideration by the Missouri General Assembly  
Updated 1/23/2020

The 100th Missouri General Assembly convenes its second regular session on January 8, 2019. More than 100 bills under consideration may affect the health of Missourians. To help our partners navigate the state policymaking process, Missouri Foundation for Health tracks health-related bills and provides updates through the end of the legislative session in May.

An overview of the Missouri legislative process is available in this chart. Each step in the process has a number:

Additionally, each bill is categorized by health-related topic(s), including: private insurance; health care value; safety net (TANF, SNAP, Medicaid/MO HealthNet, EITC, etc.); Behavioral Health (substance use and mental health); children & infants; criminal justice; health care workforce; health care facilities; prescription drugs; women’s health; oral health; prevention & awareness (public health, infrastructure, and healthy and active living); firearms & violence prevention; budget & tax; and other (includes legal, civil rights, etc.).
